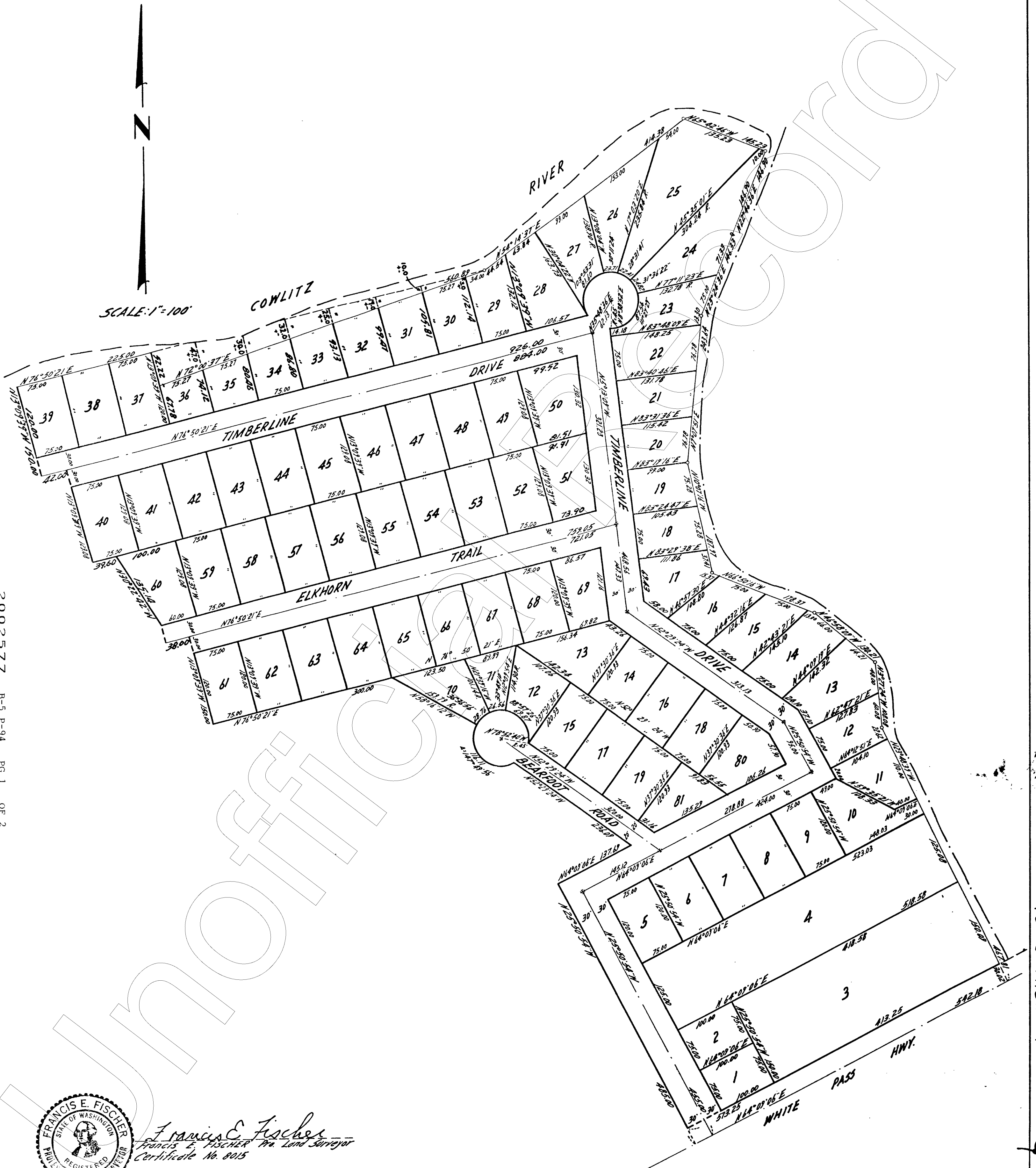

DESCRIPTION

Beginning at the intersection of Coal Creek Drive and the center line of WHITE PASS HWY. as recorded in the plat of Timberline Village in Section 1, Twp. 13 N, R9 E, W.M. in Lewis County, Washington; thence S 64° 08' 06" W 922.49 ft. to the point of beginning; thence N 25° 50' 54" W 485.00 ft.; thence N 64° 08' 06" E 137.69 ft.; thence N 52° 22' 24" W 236.09 ft.; thence around a curve to the right with a radius of 450.0 ft. through an arc of 147° 42' 55" 16.11 ft.; thence N 58° 16' 12" W 159.79 ft.; thence S 76° 50' 21" W 300.00 ft.; thence N 13° 09' 39" W 150.00 ft.; thence S 76° 50' 21" W 380.00 ft.; thence N 13° 09' 39" W 30.00 ft.; thence N 70° 22' 42" W 135.14 ft.; thence S 76° 50' 21" W 38.40 ft.; thence N 13° 09' 39" W 159.08 ft.; thence S 76° 50' 21" W 42.00 ft.; thence N 13° 09' 39" W 165 ft. more or less to the south bank of Cowlitz River; thence easterly along the bank of said river 1250 ft. more or less to the center line of Coal Creek; thence southerly along said center line of Coal Creek to the intersection with White Pass Hwy.; thence S 64° 08' 06" W along the center line of White Pass Hwy. to the true point of beginning; EXCEPT the State Hwy. right of way reference this description to sheet 2 of 2 of this plat.
